**Other Business:**

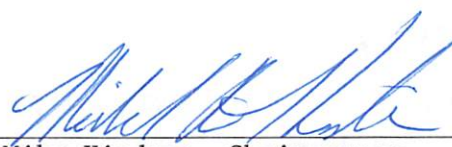
